

# What is Label Forum Japan

*Label Forum Japan is a co-creation platform that connects technology, functionality, and sustainability within the label industry through its combination of an international conference and exhibition.*



## Recognized as Japan's Leading Global Event for the Label Industry

Label Forum Japan originated with Label Summit Japan 2006, held at Tokyo International Forum.

The event was organized by the UK-based Tarsus Group—operator of the Labelexpo Global Series (to be rebranded as LOUPE in 2026)—with support from Label Shimbun, becoming Japan's first professional event to connect the global and domestic label industries.

Since 2008, under a continuing partnership with Tarsus, Label Shimbun has taken over the event and renamed it Label Forum Japan.

With its three core elements—Conference, Exhibition, and VIP Reception—the forum has been held biennially, developing into a professional platform that drives technological innovation and market collaboration in Japan and beyond.

After a hiatus during the pandemic, the exhibition returned in 2024, relocating to Tokyo Big Sight, Japan's largest exhibition venue.

With an increased focus on live equipment demonstrations, the event attracted a diverse range of exhibitors—including label converters and materials manufacturers—and achieved record numbers of visitors and participants.

The 2026 edition will further evolve into the only comprehensive event in Japan covering the entire label value chain, from raw materials and production to finished products.

In addition to expanding the area dedicated to label applications, the forum will offer a multifaceted view of “the value of labels.”

The long-awaited international conference will also return, marking a new stage for Japan's label industry.

# POINT

## Highlights of Label Forum Japan 2026

### ***1. Conference returns as the exhibition enters a new stage at Tokyo Big Sight***

Label Forum Japan 2026 will once again take place at Tokyo Big Sight, following the previous edition. This time, the international conference will be held at Tokyo Big Sight's largest conference venue, the International Conference Hall, over two days. Key speakers from Japan and overseas—including brand owners, label users, industry experts, label converters, and material suppliers—will share insights on current challenges and future directions toward a more sustain-

able label industry.

In parallel, the exhibition will further expand its “Label Pavilion,” evolving into a showcase that covers the entire value chain—from label manufacturing to finished products.

By combining live demonstrations and exhibits from both production and branding perspectives, the event aims to provide an even more comprehensive view of “the value of labels.”

### ***2. Strengthening cross-industry synergy with other major exhibitions***

By coinciding with major concurrent shows such as TOKYO PACK 2026 – The International Packaging Exhibition and Health Ingredients Japan 2026 (Hi Japan/FiT Japan), Label Forum Japan 2026 will strengthen its cross-industry collaboration, connecting the label sector with the broader packaging and food industries.

This alignment is expected to increase visitor circulation and deliver greater business networking and information-sharing opportunities for all participants.

### ***3. Expanded Label Pavilion — From label production to finished products***

The 2026 exhibition will feature an expanded Label Pavilion, offering a comprehensive overview of the entire label production process through to final applications. Alongside printing and finishing technologies, the latest label products representing both manufacturing and branding perspectives will be presented, highlighting

innovations in design, functionality, and value creation. A Label Contest, decided by on-site visitor voting, will also return—recognizing outstanding works and creative excellence across multiple categories, further showcasing the industry’s craftsmanship and technical capabilities.

### ***4. Industry association’s annual convention held in conjunction — Strengthening networking opportunities***

On the final day, October 16 (Friday), the 68th Annual Convention of the Japan Federation of Label Printing Industries (JFLP) will be held at the Reception Hall, Conference Tower, Tokyo Big Sight. The program includes an official ceremony and networking reception.

By coordinating its schedule with this major industry event, Label Forum Japan aims to further energize Japan’s label market and enhance networking opportunities among exhibitors, visitors, and industry professionals.



- Listing on the official website
- Free display space in the “Label Pavilion”
- One 2-day conference ticket

## ► What is Not Included in the Exhibition Fee

- Tables, tablecloths, chairs, name plates
- Electricity supply, electrical construction work, and electricity usage fees
- Communication line installation and usage fees
- Booth interior decorations
- Carpeting and other decorative materials
- Meals (boxed lunches)
- Rental equipment fees
- Insurance
- Parking fees during move-in/out and exhibition period
- Disposal fees for garbage and leftover materials during move-in/out and exhibition period

## ► Booth specifications



Optional booth items will be announced at the “Exhibitor Briefing Session” scheduled for July 2026 and in the Exhibitor Guidebook. In addition, starting this year, a dedicated online application system will be introduced, allowing exhibitors to manage all procedures—including those other than the exhibition application—through a centralized platform.

## ► Exhibitor Application Deadline

**[Thursday, April 30, 2026]**

The application will be considered complete once the organizer receives and confirms the Exhibitor Application Form, and the exhibitor has completed the application procedures (exhibition contract).

If all booths are filled before the above deadline, applications will close earlier. Please check availability with the organizer.

If booths fill before the deadline, applications will be accepted in the order received, and exhibitors will be contacted accordingly.

## ► Joint Exhibitors

When two or more companies apply jointly, one company must act as the representative applicant.

The representative company shall receive all communications from the organizer and handle all application-related procedures collectively.

※ All administrative communication, distribution of exhibitor passes, and delivery of visitor invitation materials will be handled only through the representative company.

## ► How to Apply

Please complete the required fields in the attached Exhibitor Application Form and submit it to the Secretariat via e-mail or fax.

## ► Changes or Cancellation After Contract Signing

Cancellation or termination of the exhibition contract is not permitted in principle.

If unavoidable circumstances arise and the organizer acknowledges the reason as unavoidable, changes or cancellations may be accepted.

Regardless of whether booth fees have been paid, cancellation fees listed below will apply based on the date the organizer receives written notice of change or cancellation.

The contract will be considered terminated once the organizer confirms receipt of the cancellation notice and applicable fees.

## ► Invoicing and Payment

Booth fees will be invoiced in a single payment once the application procedure is complete.

※ Invoices will be issued within 60 days after the application is accepted. Please transfer payment in Japanese yen to the designated bank account.

※ Bank transfer fees must be borne by the exhibitor.

※ Personal checks or cash payments are not accepted.

※ Exhibitors will not be entitled to use their booth until full payment of booth fees has been confirmed.

## ► Booth Allocation

Booth locations will be determined by the organizer based on exhibit content, application order, number of booths, booth configuration, company type, and the exhibitor's move-in schedule.

The booth layout will be announced at the Online Exhibitor Briefing scheduled for July 2026. Please note that specific booth requests cannot be accommodated.

## ► Postponement or Cancellation of the Exhibition

If the organizer determines that the exhibition cannot be held due to natural disasters, accidents, epidemics, or other force majeure circumstances, the exhibition may be postponed or cancelled.

If the exhibition is cancelled, the organizer will refund the booth fee after deducting expenses already incurred.

If postponed, booth fees already paid will be applied to the rescheduled exhibition.

In the event of cancellation due to force majeure, exhibitors shall not claim any compensation for damages or losses other than the refund described above.

## ► Obtaining Visas

Exhibitors requiring visas to enter Japan must prepare and submit all necessary documents, including invitation letters, at their own responsibility and cost.

The organizer may issue invitation letters only after confirming the exhibitor's application and payment; however, issuance is not guaranteed.

If the Japanese embassy or consulate does not approve the visa, or the visa cannot be issued in time, the organizer bears no responsibility and no refund or compensation will be provided.


